Admission methods for the Master's Degree with entry requirements and academic knowledge assessment in:

Economics and communication for management and innovation

Faculty of Economics - Political Science, Sociology, Communication Inter-university with Tuscia University Class: LM-77; code to be entered on Infostud: **33444** Degree programme delivered in English language

1. Stages of the procedure

For admission to the master's degree, it is required to:

- a. Pay the €10,00 fee in compliance with the methods and deadlines indicated in section 3.
- b. Wait for the outcome of the entry requirements assessment. If the requirements are not met, it is possible to acquire the missing credits by passing single exams. The methods and costs are set out in "Single Courses" of the Student Regulations Go to the Student Regulations
- Carry out the academic knowledge assessment in the modalities indicated in section 4.
- d. Proceed to enrolment by paying the master's degree enrolment tuition fees in accordance with the procedures and deadlines indicated in section 5. Enrolment can only take place when the Student Affairs Office sends an email notification of the positive outcome of entry requirements and academic knowledge assessment.

For candidates from other Italian universities

After paying the €10 fee, candidates from other Italian universities must send to the student affairs office (using the specific form accessible at the link https://forms.gle/QduqgeacF3tWuy2u7):

- self-certification of the educational qualification obtained with indication of the graduation grade and degree Class;
- self-certification of the exams taken, the number of ECTS for each exam, the Scientific-Disciplinary Sectors corresponding to the subjects;
- a copy of the payment of the €10,00 fee.

For candidates who have not graduated yet

Candidates who have not yet graduated (from Sapienza University of Rome or other universities) may also apply for entry requirements assessment, without prejudice to the

obligation to graduate by January 24, 2026 (for those who have not yet graduated from Sapienza University of Rome) and by December 20, 2025 (for those who have not yet graduated from other Italian and international universities).

Requirements will be assessed only after the degree has been obtained.

For this purpose, those coming from other universities must send the self-certifications referred to in the previous paragraph, including their final grade and degree class.

For candidates coming from foreign countries and/or in possession of a qualification obtained in a non-Italian education system

Procedures for candidates coming from foreign countries are indicated in section 6.

2. Entry requirements

To enrol in the Degree Programme in Economics and Communication for Management and Innovation applicants must satisfy one of the following conditions:

I) hold a degree in class L-18 or L-33 or in the corresponding classes activated pursuant to Ministerial Decree no. 509 of November 3, 1999 or hold a degree in class L-20 provided they have at least 60 ECTS completed in the following foundation and core Scientific-Disciplinary Sectors (SSDs) envisaged in the tables attached to the Ministerial Decree December 19, 2024 for class L-18 and 33 in compliance with the minimum distribution constraints established by the Programme regulations between the subject areas (minimum coverage of three subject areas and attainment of at least 18 ECTS in the business area):

II) for applicants who graduated from other degree classes, possession of at least 72 ECTS completed in the following foundation and core Scientific-Disciplinary Sectors (SSDs) envisaged in the tables attached to the Ministerial Decree December 19, 2024, for class L-18 and 33 in compliance with the minimum distribution constraints established by the Programme regulations between the subject areas (at least three subject areas covered and at least 18 ECTS in the business area).

3. Entry requirements assessment

The assessment of entry requirements is requested by paying a fee of €10,00 from July 2, 2025, to one of the following dates of your choice:

- September 16, 2025 (only date available for non-EU candidates who request a student visa)
- October 16, 2025
- November 18, 2025
- December 16, 2025
- January 15, 2026 (date reserved for those who have already graduated or are about to graduate from Sapienza University of Rome).

Payment is generated on the Infostud system.

Payment is made online via PagoPA (direct payment).

The code to be entered in the system is 33444.

The outcome of the entry requirements assessment will be communicated to the institutional mailbox (if activated) or to the personal email address declared on Infostud.

4. Academic knowledge assessment

Candidates who meet the above-mentioned requirements, in order to enrol in the degree programme, must also undergo a test aimed at assessing their academic knowledge.

Those who have completed a Bachelor's degree in classes 17 and 28 (ex Ministerial Decree 509/99) and L-18, L-33 and L-20 (ex Ministerial Decree 270/04) are exempt from taking the academic knowledge assessment test.

Candidates with a degree in other classes who have obtained a mark no lower than 90/110 are also exempt from taking the academic knowledge assessment test.

For all the others, the Degree Programme Board will provide for assessment by means of an individual interview or group test or university career assessment, with particular regard to the exams of the foundation and core Scientific-Disciplinary Sectors.

The assessment of academic knowledge will also concern English language proficiency at a minimum level of B2 (assessment not necessary in the case of those who hold a three-year degree entirely delivered in English).

5. Enrolment

Enrolment is obtained through payment of the enrolment tuition fees, after successful completion of the entry requirements and academic knowledge assessment.

6. Candidates with an educational qualification obtained in a non-Italian education system

Procedures differ according to nationality and country of residence.

For those with citizenship in non-EU countries, residing abroad and applying for a study visa, and for those from China and participating in the Marco Polo project

In these cases, it is necessary to have the mandatory pre-acceptance letter.

The procedures to be followed are indicated in section 7 of the International Student Office page Read section 7

For those with Italian citizenship, for those with citizenship in EU countries (regardless of country of residence) and for those with citizenship in non-EU countries with a residence permit in Italy

Following the successful outcome of the entry requirements assessment, or upon receipt of the pre-acceptance letter, those in possession of an educational qualification obtained in a non-Italian education system must complete the enrolment procedure for the two-year Master's degree programme as indicated in section 4 of the International Student Office page
