1. Access to degree programmes

To access the degree programmes listed in this call for applications, you must:

- register with University;
- apply for a study visa if you are a non-EU citizen residing abroad ([point 2.2](#));
- pay the test participation fee on University ([point 4.3](#));
- take the test ([point 5](#));
- pay the enrolment fees by the deadlines, if you are successful in the ranking list ([point 8](#)).

2. Requirements and conditions

2.1 - For applicants who are Italian citizens, citizens of another EU country, or citizens of a non-EU country with a valid residence permit in Italy (non EU equivalents)

If you have one of the citizenships below:

- Italian;
- EU country other than Italy;
- non-EU with a valid residence permit in Italy (Art. 26 of Law no. 189/2002)

To be eligible for one of the degree programmes in this call for applications, you must have obtained, or be in the process of obtaining, a **secondary school diploma** in 2026. If you have a qualification obtained in a foreign secondary education system, you must carefully read the list of required documents on the Sapienza website [Go to the page](#).

2.2 - For applicants who are citizens of a non EU country and are applying for a student visa

If you are a citizen of a non-EU country and you reside abroad and need to apply for a study visa, you must meet the following requirements in order to access one of the degree programmes in this call for applications:

- a **secondary school diploma** obtained or to be obtained in 2026. If you have a qualification obtained in a foreign secondary education system, you must carefully read the list of required documents on the Sapienza website [Go to the page](#);
- an **online pre-enrolment application**, to obtain a study visa, 'University enrolment' for the 2026-27 academic year on the University website (<https://www.universitaly.it/>), which must be completed and submitted by **30 June 2026**. Pre-enrolment on the University website is mandatory in order to obtain a study visa. Please note that pre-enrolment alone does not grant admission to study programmes. To enrol, you must complete the procedures set out in this call for applications.

Please note that in the case of candidates with dual citizenship, one of which is Italian or EU, the latter prevails.

Those who already hold an academic qualification (obtained in Italy or abroad) and those who come from other degree programmes or university diplomas must follow the procedures outlined below and take the relevant admission test if they enrol on the first year of the degree programme.

2.3 - Enrolment on years subsequent to the first due to transfer, change of degree programme or shortening of the degree programme

Enrolment on subsequent years is only possible by participating in a specific selection procedure. This procedure will only be activated if places are available for years subsequent to the first, based on the annual planning decrees.

In this case, you may submit an application for enrolment on years subsequent to the first following a transfer from another Sapienza degree programme, a transfer from a degree programme at another university or a shortening of the degree programme (if you already have another degree or have taken exams in another educational programme).

3. Admission test

3.1 - Date and time of the test

Sapienza University of Rome

The admission test will be held in person on **29 September 2026** at **Sapienza University of Rome** and at the locations abroad listed in [Annex 4](#).

If you taking the test at Sapienza you must arrive by 11:30 a.m.

The exam will begin at 13:30.

Those taking the exam at Sapienza will be organised by age for distribution, with the exception of twins. This list will be published by September 25, 2026, in the degree programme catalogue

(<https://corsidilaurea.uniroma1.it/en>) on the degree programme page.

Foreign locations

The exam will take place at the foreign locations listed in [Annex 4](#).

The time of the exam at the **foreign locations** will be confirmed in a subsequent notice from the MUR, which will be published both on the MUR website and in the degree programme catalogue

(<https://corsidilaurea.uniroma1.it/en>) on the degree programme page.

Note 2 - Places reserved for citizens of non-EU countries who are permanently resident abroad and require an entry visa ([Annex 3](#)).

4. Registration for the test

Registration opens on **26 August 2026** and closes at 3 p.m. (GMT+2) on **9 September 2026**.

To register for the test, you must, under penalty of exclusion:

- connect to the University website www.universitaly.it;
- enter the personal data requested ([point 4.1](#));
- indicate your preferred location and order of preference ([point 4.2](#));
- pay the registration fee using the methods indicated on the University website ([point 4.3](#));
- if you choose to take the test at Sapienza, you must also register with Infostud ([point 4.4](#)).

This procedure is mandatory

- This applies to Italian citizens, citizens of other EU countries, and citizens of non-EU countries with a valid residence permit in Italy;
- this also applies to citizens of non-EU countries who are permanently resident abroad and required an entry visa for study purposes "University enrolment" for the academic year 2026-2027, on the University website (<https://www.universitaly.it/en>), filled in and sent compulsorily by June 30, 2026.

Please note

The statements relating to personal data are **substitute declarations of certification** pursuant to Article 46 of Presidential Decree No. 445/2000. **In the event of a false declaration**, Articles 75 and 76 of the aforementioned decree shall apply.

If you do not have an email address, the information referred to in note (a) (telephone number) must be provided and will be used exclusively to send you communications relating to the selection procedures.

All information provided will be used exclusively for activities relating to admission to the single-cycle master's degree programme for which you are applying.

All communications relating to the test will be sent to the email address provided at the time of your test registration. **We therefore recommend that you check your email address regularly and update it promptly if it changes.**

4.2 - Order of preference of locations on University

During the registration process, you will also be required to **indicate your preferred university locations**. This procedure is mandatory for the test to take place, otherwise you will be excluded from the test.

If you wish to take the test abroad, you must select a location from those listed in [Annex 4](#).

Please note

The location that you indicate as your first preference is where you will take the test, if you wish to take it in Italy.

If you are a citizen of a non-EU country, reside abroad and require a study visa, and wish to take the test at an Italian location, the location you indicate as your first preference will be the one where you will have to take the test and must coincide with the location of the Italian university where you submitted your online pre-enrolment application (by June 30, 2026), in order to obtain an entry visa for study purposes 'University enrolment' for the 2026-2027 academic year. This application must have been submitted via the University website (<https://www.universitaly.it/en>).

Please note

The order of preferences cannot be changed after 3 p.m. (GMT+2) on 9 September 2026, after which it will be irrevocable and non-modifiable; in any case, the last 'confirmation' submitted before this deadline will be considered valid.

No exceptions will be made regarding the location of the test.

4.3 - Payment of the fee on Universitaly

Payment of the participation fee for the test must be made only in the manner published on the website www.universitaly.it when registration opens.

Failure to pay the fee will result in exclusion from the test.

Payment must be accompanied by the online registration receipt, otherwise you will be excluded from the test.

4.4 - Registration with Infostud

If you wish to take the test at Sapienza, you must register with the Infostud system via the website between **7 August 2026** and **9 September 2026**.

You can register by entering your details in the form available on the Sapienza website at the following link:

If you are an Italian citizen, you will need your SPID or CIE credentials.

Please note

If you are already registered with Infostud, you must check/enter your email address on the Idm dashboard by logging in with your SPID/CIE credentials or with your student ID number and password at <https://idm.uniroma1.it/>.

The email address entered on Infostud at the time of registration must be correct, valid and regularly checked during the procedure, as it will be used for communications from the university.

4.5 - Disabilities or SLDs

If you have a certified disability or impairment, or a diagnosis of SLD (specific learning disability), you are entitled to additional time to complete the test and may request special assistance relating to your needs. You can submit your request by the test registration deadline using the procedures set out in [Annex 5](#).

5. Test procedure

5.1 - Identification procedures

You will only be allowed to access your assigned workstation once the identification procedures have been completed, so **you must show a valid ID document**.

You may only take the test at your assigned workstation; otherwise the test will be cancelled.

Candidates will be seated according to their age, except for twins.

5.2 - Materials for the test

After the identification procedures, you will be given the following materials:

- a black ballpoint pen;
- a 'University label' with your name and barcode;
- a sheet of instructions on how to complete the answer sheet.

Before the start of the test, you will be given a sealed envelope containing:

- a. a form for personal details, which candidates must complete, without including any identification codes;
- b. the questions for the admission test bearing the same identification code as the envelope, and two sheets of paper for rough drafts;
- c. an answer sheet bearing the same identification code as the envelope;
- d. a sheet bearing the envelope's identification code, the name of the university and the degree programme to which the test refers.

Please note: If that if it becomes necessary to replace any of the documents in points b) and c) during the test, the entire envelope must be replaced, as the identification code must be the same on both the envelope and its contents.

Corrections or marks made on the personal data form do not require it to be replaced. The personal data form will only be replaced if the corrections or marks make it difficult to identify the candidate. In this case, the board will replace the personal data form with one from the reserve envelopes and record this in the exam room report.

Replacement of the registration form shall never entail the replacement of the entire envelope.

If there are reports of irregularities regarding the envelope received, the President of the board will verify its authenticity and replace the envelope if necessary. This operation must be recorded in the minutes of the session together with the reasons.

5.3 - Requirements and prohibitions

The board of supervisors during the test will comprise a sector chairperson, an administrative manager, and administrative staff (in numbers proportionate to the number of candidates per room).

During the test, you must comply with the following requirements:

- **you may not, under penalty of cancellation of the test, bring into or use in the competition venue:**
 - o mobile phones, PDAs, smartphones, smartwatches, tablets, earphones, webcams or other similar equipment;
 - o pens, pencils, or any other stationery in your personal possession;
 - o manuals, textbooks or reproductions thereof, even partial; handwritten notes; blank sheets of paper; and reference material.
- **you must not, under penalty of cancellation of the test, interact with other candidates** or attempt to copy or exchange any material, including personal details and answer sheets.
- **You must use only the black pens** provided by the university or the foreign service office.
- **You must mark your chosen answer by placing an X** in the corresponding box (by drawing diagonal lines through the square of the answer).
- **you may correct an answer once and only once** by completely blackening the box previously marked with an X and choosing another answer. In any case, there must be an X in only one of the five boxes for the relevant mark to be awarded.
- **To indicate that you do NOT wish to answer**, you must cross out the circle corresponding to its serial number. This indication cannot be changed once marked; if you do not mark any of the answer boxes, the answer will still be considered not given, even if you do not cross out the circle.

5.4 - Requirements at the end of the test

At the end of the test, you must go to the designated submission station, where you will find:

- a box for handing in the personal data form, with a copy of the form on one side;
- pairs of adhesive labels with barcodes;
- a pen.

Without help from the board, who will remain at a safe distance, you must:

- choose a pair of identical adhesive labels;
- apply one label to the answer sheet and the other to the personal data form, ensuring that the alphanumeric codes printed on the chosen pair of labels match;
- sign the declaration of truthfulness of the personal data and of the correspondence of the codes on the labels applied to the personal data sheet and the answer sheet at the bottom of the personal data sheet using only the pen provided at the designated station.

Please note

When inserting the registration form and the answer sheet into the appropriate containers, **do not use pens, pencils or any other writing instruments to make changes, additions or corrections to the answer sheet. Failure to comply with this instruction will result in the board cancelling the test and not awarding the relevant score.**

Once you have completed these steps, you must:

- place the personal information form in the closed container at the designated submission station;
- go to the designated submission station where you must place the answer sheet face down in the appropriate closed container.

Please note

The answer sheet must not be signed or marked by you or members of the board of examiners;

otherwise the board of examiners will cancel the exam and the corresponding score will not be awarded.

The board of examiners must retain:

1. the answer sheets intended for Cineca, placed in the appropriate boxes;
2. the personal data sheets, placed in the appropriate boxes;
3. the sheets on which the exam questions are printed;
4. the envelope control sheet;
5. the two sheets for rough drafts.

At the end of the test, the chairperson of the board of examiners, in the presence of the candidates who were called upon at the beginning of the test to verify the integrity of the boxes or four other candidates chosen at random if they are unable to do so, shall:

- a. close the containers with the answer forms inside, after counting them;
- b. close the appropriate containers with the personal data sheets;
- c. sign the labels used to close the containers;
- d. invite the four candidates to sign the same label already signed by the chairperson of the board of examiners;
- e. pack other containers in which the returned envelopes that have been replaced, the envelopes from which the personal data forms have been removed, and the unused envelopes must be counted, enclosed and sealed, together with the declaration certifying the integrity of the boxes, the number of envelopes assigned, and a copy of the minutes of the session.

6. Test subjects and assessment criteria

The content of the tests, which is identical throughout the country and is prepared by the Ministry of University and Research (MUR).

6.1 - Number of questions and time allowed

The admission test consists of sixty (60) questions with five (5) answer options. You must choose only option, discarding incorrect, arbitrary or unlikely conclusions. The topics covered are related to:

- reading skills and knowledge acquired during your studies;
- logical reasoning and problems;
- biology;
- chemistry;
- physics and mathematics.

Based on the programmes set out in [Annex 2](#), the following will be provided:

- four (4) questions on reading skills and knowledge acquired during your studies;
- five (5) questions on logical reasoning and problems;
- twenty-three (23) questions on biology;
- fifteen (15) questions on chemistry;
- thirteen (13) questions on physics and mathematics.

The test will last 100 minutes.

6.2 - Points awarded for answers

MUR/Cineca will assess the test using the following criteria:

- 1.5** points for each correct answer;
- 0** points for each unanswered;
- 0.4** points for each incorrect answer.

In the event of a tie, the following criteria will be applied in order:

- a) The score obtained in the questions relating to biology, chemistry, physics and mathematics, logical reasoning and problems, reading skills and knowledge acquired during studies will prevail in descending order.
- b) possession of the language certifications referred to in [Annex 1](#) by **9 September 2026**, as declared at the time of registration for the test, shall prevail. Candidates are expected to self-certify their possession of the language certifications required for this application in accordance with Article 46 of Presidential Decree No. 445/2000. The administrations involved in this procedure reserve the right to verify the accuracy of the statements made by candidates at any stage of the procedure, in accordance with the relevant legislation in force. Candidates must therefore provide all the information necessary to allow the relevant checks to be carried out. If the submitted documentation contains false or misleading statements, any enrolment will be cancelled, any benefits granted will be recovered and any university fees paid will be retained, without prejudice to the penalties provided for by the criminal code and special laws on the subject, and the declarant will be exposed to compensation for damages by the other parties.
- c) In the event of a tie between one or more candidates with a disability certificate of at least 66% or a certified disability as referred to in Law No. 104 of 1992, Article 3, paragraph 3, and one or more candidates who do not fall into these categories, preference will be given to the candidate(s) with a disability certificate of at least 66% or with a certified disability as referred to in Law No. 104 of 1992, Article 3, paragraph 3.
- d) Outside the case referred to in (c), in the event of further equality, the younger candidate shall prevail.

6.3 - Score thresholds for inclusion in the ranking

Ministerial Decree No. 1005 of 6 August 2026 established that:

- **if you are an Italian citizen**, a citizen of an EU country, or a non-EU citizen with a valid residence permit in Italy (Article 26 of Law No. 189/2002), you will be eligible for the ranking if you obtain a final score of **20 or higher** in the test.
- **if you are a citizen of a non-EU country and reside abroad**, you will be eligible for the ranking list if you obtain a final score **higher than zero** in the test.

7. Additional Educational Requirements (OFA)

Following the test results, the faculty will assign additional educational requirements (OFA) in biology and/or chemistry if you are placed on the ranking list with a total score **lower than 30**, and if you obtained a score **lower than 25% of the maximum possible** in the above subjects.

Therefore, the thresholds for the subjects, below which additional educational requirements (OFA) will be assigned, are as follows:

Subject	Maximum score obtainable	OFA threshold
Biology	34.5	8.6
Chemistry	22.5	5.6

You can fulfil the additional educational requirements (OFA):

- if you pass the curricular exam for the subject covered by the OFA (Biology or Chemistry).

or

- if you pass a specific remedial test (OFA test) organised by the Faculty.

Special remedial courses in Biology and Chemistry are available to help students fulfil the OFA requirements. These degree programmes will be held according to a schedule that will be posted on the web pages of the respective degree programmes, in the degree programme catalogue, under 'Attendance':

This page will also publish the dates and procedures for taking the OFA remedial tests, as well as all other relevant information.

Please note

The OFA must be passed within the first year of the degree programme. If you do not pass the OFA you have to repeat the first year and you will not be able to sit exams for years subsequent to the first, starting from the 2027–2028 academic year.

8. Rankings

Based on the score obtained in the test, calculated by Cineca according to the criteria set out in Ministerial Decree No. 1005 of 6 August 2026, a **single national ranking** will be drawn up for candidates with citizenship:

- in Italy;
- in EU countries;
- in non-EU countries, provided they have a valid residence permit in Italy (Article 26 of Law No. 189/2002).

The ranking list for candidates who are legally resident abroad in **non-EU countries** and applying for a study visa is determined by the university and published on the web page of the respective degree programmes, in the 'Enrolment' section of the Degree Programme Catalogue:

Note: the status of 'eligible non-winner' only applies to the current selection procedure and does not entitle the candidate to access degree programmes in subsequent academic years.

8.1 - Publication of the national ranking

The results of the national ranking will be published on the website www.universitaly.it in the reserved area.

On **8 October 2026**, CINECA, on behalf of the MUR, will publish in the reserved area only the **score obtained according to the label code** and in compliance with the rules for the protection of personal data. These data will remain available in the reserved area until the conclusion of the procedures.

From **19 October 2026**, candidates will be able to view their application, score and personal details in their reserved area.

On **26 October 2026**, the national merit ranking list will be published in the reserved area.

8.2 - 'Assigned' and 'Reserved' status

The ranking list indicates the following for each candidate:

- the score obtained;
- their position in the ranking;
- the status 'Assigned', 'Reserved' or 'Waiting'.

If you are listed as **'Assigned'** in the ranking or in subsequent scrolls, it means that you have been offered a place for your **first useful preference**, i.e. the best available option for your chosen location and degree programme, based on your score and the number of places available.

If this applies to you, you must enrol by the deadline for the degree programme/location in which you are listed as 'Assigned'. If you do not enrol by the deadline, you will lose your right to enrol, and the reason for the delay will not be taken into account.

If you are listed as **'Reserved'** in the ranking or in subsequent scrolls, it means that you are eligible for one of the available places on a degree programme or at a location that is your **second** choice after your first preference. You can either enrol on the degree programme/at the location where you are listed as 'Reserved', or wait for the next round to see if any places become available for a more favourable one of your preferences.

If you enrol on a degree programme for which you are listed as 'Reserved', all other preferences you have expressed will be automatically cancelled.

8.3 - Enrolment deadlines

Within four days from 26 October 2026 inclusive (excluding Saturdays and public holidays):

- if you are in the **'Assigned'** status, **you must enrol; otherwise, you will no longer be able to do so;**
- if you are in the **'Reserved'** status, **you can choose whether to enrol or wait** for the next round.

The four-day deadline (including the date of publication of the ranking list and excluding Saturdays and public holidays) **must also be respected for subsequent rankings.**

8.4 - Deadlines for confirming interest

To participate in the ranking lists, you must confirm your interest in remaining on the ranking list in the reserved area of the University website; otherwise, you will lose your place.

This must be done **within five days of 26 October 2026**, and in any case by 12 noon on the fifth day following each ranking. This includes the day on which the ranking is published, but excludes Saturdays and public holidays.

You do not need to confirm your interest if:

- you have already enrolled and paid the first instalment);
- you have withdrawn your enrolment;
- your name is associated with the status 'Places Exhausted'.

Failure to confirm your interest will result in your exclusion from subsequent scrolling of the national ranking list and you will lose your right to enrolment.

The reason for not confirming your interest is irrelevant.

Once the deadline has expired, exclusion will be communicated by means of an automatic notice in the reserved area.

If you wish, you may appeal against any notice of exclusion to the Lazio Regional Administrative Court within sixty days or to the President of the Republic within one hundred and twenty days, of its publication in the reserved area.

An appeal lodged for reasons other than exclusion, relating to failure to enrol on one of the chosen degree programmes, does not remedy the exclusion.

8.5 - Subsequent scrolling after the first ranking

On **3 November 2026**, CINECA will publish a new ranking list, based on merit and the preferences expressed using the procedures described above.

Subsequent scrolling of the rankings will follow the procedures and timelines indicated in the previous points.

As set out in Annex 2 of Ministerial Decree No. 1005 of 6 August 2026, no new ranking lists will be produced for any further requests for transfer or withdrawal after all places have been filled.

9. Enrolment

Enrolment is confirmed upon payment of the enrolment fees for the 2026-27 academic year, plus a €16.00 stamp duty and the regional tax.

It is therefore extremely important to have obtained the **ISEE calculation for the right to university education** at this stage, in order to take advantage of the exemptions and concessions provided for on the basis of this indicator ([Annex 6](#)).

For the purposes of shortening the duration of the course and/or recognising prior academic achievements, only courses taken and recorded in English will be taken into account.

Courses taught or taken in a language other than English will not be assessed or recognised in any way.

9.1 - For applicants with a qualification from a foreign secondary education system

If you are successful in the ranking and hold a qualification from a foreign secondary education system, you must follow the instructions on the Sapienza website to enrol by the deadlines set out in [point 8](#) [Go to page](#) (for foreign qualifications, see Annex 3 of this call for applications [point A3.5](#)).

9.2 - For applicants transferring from another Sapienza degree programme

If you are successful in the ranking, are currently enrolled on another Sapienza degree programme, and wish to request recognition of the exams you have taken on your previous degree programme, you must submit a transfer application using the 'Passaggio di corso con riconoscimento esami' (Degree Programme Transfer with Exam Recognition) form, which is available in the 'Annexes' section on the following page of the university website <https://www.uniroma1.it/en/pagina/student-forms>.

The transfer application must be sent by email no later than the deadline for payment of the degree programme enrolment fees indicated in [point 8](#) including both the Student Affairs Office of your current degree programme and the Student Affairs Office of the programme in which you wish to enrol ([point 12](#)).

In the email addressed to the secretariats, you must state your position on the ranking and confirm that this position falls within the limit of places specified in the call for applications.

Please note: once you have submitted your transfer application, you will not be able to take exams for your original programme.

9.3 - For applicants transferring from another Italian university

If you are successful in the ranking, are currently enrolled on a degree programme at another Italian university, and wish to apply for the recognition of exams taken on your previous degree programme, you must pay the enrolment fee for your chosen new degree programme by the deadlines specified in [point 8](#) and, within ten days of paying the fees, you must submit a transfer application. Please note: once you have paid the transfer fee, you will no longer be able to sit exams for your previous degree programme.

9.4 - For applicants already holding an Italian university qualification

If you are successful in the ranking, already hold a degree from an Italian university, and wish to apply for the recognition of university credits earned during your previous studies **within 15 calendar days of paying the first instalment of the degree programme fees**, you must submit your application by following the instructions on the Sapienza website. 10. Compulsory vaccinations

Within 60 days of paying the first instalment, you must undergo a Mantoux tuberculin test, in accordance with the tuberculosis control guidelines (Agreement of 07/02/2013 of the State-Regions Conference published in the Official Gazette no. 63 of 15/03/2013) and Presidential Decree no. 465 of 7/11/2001, which regulates tuberculosis vaccination.

The tuberculin test must be carried out at your local health authority.

You will also need to be vaccinated against viral hepatitis B in accordance with Law No. 165 of 27/5/1991.

This vaccine is offered free of charge to individuals working, studying or volunteering in the health sector. This vaccine must also be administered at your local health authority.

Instructions

- a. Have the required tests and vaccinations carried out.
- b. Ask your doctor (GP or another doctor you trust) to complete, sign and stamp the medical certification form: [Go to the form](#);
- c. Keep all documentation and show it if requested by the healthcare facility you are attending.

11.1 - If you are a citizens of a non-EU country, hold a residence permit for study purposes and wish to withdraw from enrolment

If you are a citizen of a non-EU country and, having obtained an entry visa for study purposes, you hold a residence permit for study purposes, by withdrawing your enrolment at Sapienza University or other universities, **you will lose the requirements for residence in Italy, and therefore your residence permit for study purposes will be revoked**. To re-enrol, you will need to wait for the next academic year 2027-2028, return to your country of origin and complete the pre-enrolment procedures via the University online platform (<https://www.universitaly.it/>)

Annex 2 - Test syllabus

Syllabuses relating to the questions in the admission tests for the Master's degree programmes in Medicine and Surgery, and in Dentistry and Dental Prosthetics, taught in English

Admission to these degree programmes requires the ability to understand and analyse various types of written text, conduct logical and mathematical reasoning, and demonstrate general knowledge, particularly in history, geography, social and institutional matters and mathematics, chemistry, physics and biology.

The skills and knowledge required correspond to the preparation promoted by educational institutions that organise educational and teaching activities consistent with the National Guidelines for High Schools and the Guidelines for Technical and Vocational Institutes, especially in view of the State Exams.

Reading skills and knowledge acquired during studies

The ability to understand written texts in English of different types and with different communicative purposes is a cross-curricular skill, given that all types of questions will be formulated in English, including the use of symbolic language.

The following skills will also be assessed specifically:

- understanding abstract, uncommon or specialised vocabulary in real contexts;
- identifying phenomena of textual cohesion and coherence;
- extracting and inferring specific information from the text.

These skills will be assessed using short scientific essays, classic and contemporary fiction, or short articles on current affairs from daily newspapers and general or specialist magazines.

Using short texts of various types and on various topics, the assessment will cover the skills acquired in previous studies, as well as general knowledge, including knowledge of supranational issues and topics of contemporary public debate.

In particular, the questions will aim to ascertain:

- the ability to orient oneself in the space and time represented, i.e. to locate important historical and cultural phenomena in space and time;
- knowledge of the main national and international institutions;
- understanding of phenomena relating to legal, economic and citizenship issues.

Logical reasoning and problems

The questions are designed to test the ability to complete a line of reasoning logically, in a manner that is consistent with the premises. These premises are stated in symbolic or verbal form and relate to cases or problems, including abstract ones, whose solution requires the use of different forms of logical reasoning.

Biology

The chemistry of living organisms.

The biological importance of weak interactions.

Organic molecules present in organisms and their functions. The role of enzymes.

The cell as the basis of life. Cell theory. Cell dimensions. Prokaryotic and eukaryotic cells, animal and plant cells. Viruses.

The cell membrane: structure and functions; transport across the membrane. Cellular structures and their specific functions.

The cell cycle and cell reproduction: mitosis and meiosis, and chromosome set and maps. •

Reproduction and heredity. Life cycles. Sexual and asexual reproduction.

Mendelian genetics: Mendel's laws and their applications. Classical genetics: the chromosome theory of heredity and models of heredity. Molecular genetics: DNA structure and duplication; the genetic code, protein synthesis. Prokaryotic DNA. The structure of eukaryotic chromosomes. Genes and gene expression regulation. Human genetics: the transmission of monofactorial and polyfactorial traits; autosomal and X-linked hereditary diseases.

Mutations. Natural and artificial selection. Evolutionary theories. The genetic basis of evolution. Heredity and environment.

Biotechnology: recombinant DNA technology and its applications.

The anatomy and physiology of animals and humans. Animal tissues. The anatomy and physiology of human systems and apparatuses and their interactions. Homeostasis.

Bioenergetics. The energy currency of cells: ATP. Oxidation-reduction reactions in living organisms. Energy processes: photosynthesis, glycolysis, aerobic respiration and fermentation.

Chemistry

The constitution of matter: states of matter; heterogeneous and homogeneous systems; compounds and elements.

The laws of ideal gases.

The structure of the atom: elementary particles; atomic number and mass numbers; isotopes, the electronic structure of the atoms of various elements.

The periodic table of elements: groups and periods; transition elements. Periodic properties of elements: atomic radius, ionisation potential, electron affinity, metallic character. The relationships between electronic structure, position in the periodic table, and the properties of elements.

Chemical bonding: ionic bonding, covalent bonding and metallic bonding. Bond energy. Polarity of bonds. Electronegativity. Intermolecular bonds.

Fundamentals of inorganic chemistry: nomenclature and main properties of inorganic compounds, such as oxides, hydroxides, acids and salts.

Chemical reactions and stoichiometry: atomic and molecular masses; Avogadro's number; the mole concept and its applications; elementary stoichiometric calculations; balancing simple reactions; and the different types of chemical reaction.

Solutions: the properties of water as a solvent, solubility and the main ways of expressing the concentration of solutions.

Equilibrium in aqueous solution.

Elements of chemical kinetics and catalysis.

Oxidation and reduction: oxidation numbers and the concepts of oxidising and reducing agents. Balancing simple reactions.

Acids and bases: the concepts of acids and bases. Acidity, neutrality and basicity of aqueous solutions; pH. Hydrolysis. Buffer solutions.

Fundamentals of organic chemistry: bonds between carbon atoms; gross and structural formulas; and the concept of isomerism. Aliphatic, alicyclic and aromatic hydrocarbons. Functional groups: alcohols, ethers and amines, aldehydes, ketones, carboxylic acids, esters and amides. Elements of nomenclature.

Mathematics

Number sets and algebra: natural, integer, rational and real numbers. Ordering and comparison; order of magnitude and scientific notation. Operations and their properties. Proportions and percentages. Powers with integer and rational exponents, and their properties. Radicals and their properties. Logarithms (base 10 and base e) and their properties. Introduction to combinatorial calculus. Algebraic expressions and polynomials. Notable products, the n th power of a binomial; the factorisation of polynomials. Algebraic fractions. First- and second-degree algebraic equations and inequalities. Systems of equations.

Functions: the fundamental concepts of functions and their graphical representations, including domain, codomain, the study of signs, continuity, maxima and minima, and increasing and decreasing functions, etc. Elementary functions: algebraic, exponential, logarithmic and trigonometric. Composite functions and inverse functions. Trigonometric equations and inequalities.

Geometry: polygons and their properties. Circumference and circle. Measurement of lengths, areas and volumes. Isometries, similarities and equivalences in the plane. Geometric loci. Angles measured in degrees and radians. The sine, cosine and tangent of an angle and their notable values. Trigonometric formulas. Resolution of triangles. The Cartesian reference system in the plane. Distance between two points and the midpoint of a segment. Equations of straight lines. Conditions of parallelism and perpendicularity. The distance of a point from a straight line. Equations of circles, parabolas, hyperbolas and ellipses, and their representation in the Cartesian plane. The Pythagorean Theorem. Euclid's theorems (the first and the second).

Probability and statistics: frequency distributions according to character type, and the main graphical representations. The notion of a random experiment and an event. Probability and frequency.

Physics

Physical quantities and their measurement: Fundamental and derived physical quantities. Systems of units of measurement: International and Technical. Multiples and submultiples. Scientific notation. Main conversions between units of measurement in different systems. Scalar quantities and vector quantities. Vectors and operations on vectors.

Kinematics: Description of motion. Speed and angular speed; acceleration and centripetal acceleration. Uniform rectilinear motion, uniformly accelerated motion, uniform circular motion and harmonic motion.

Dynamics: the concept of force as an interaction between bodies. Forces as applied vectors. The principle of inertia. Mass and the second law of motion. Examples of forces: weight, elastic force, static and dynamic friction. The third law of motion: action and reaction. Impulse and momentum. The principle of conservation of momentum. Moment of a force and angular momentum. Work and kinetic energy. Conservative forces and potential energy. The principle of conservation of mechanical energy. Power.

Fluid mechanics: Density and compressibility of fluids. Gases and liquids. Hydrostatics: pressure and the principles of Pascal, Stevino and Archimedes. The dynamics of liquids: one-dimensional motion; flow and flow rate; and the continuity equation. Ideal fluids and Bernoulli's equation. Viscous forces in real fluids.

Thermodynamics: Equilibrium and the concept of temperature, thermometers. The concept of heat and calorimetry. Modes of heat propagation. Heat capacity and specific heat. Changes of state and latent heats. The laws of perfect gases. The first and second laws of thermodynamics.

Electricity and electromagnetism: Electric charges. Forces between charges and Coulomb's law. Electric fields and potentials, and equipotential surfaces. Dielectric constant, capacitance and capacitors. Electrostatic energy. Series and parallel capacitors. Generators. Electric voltage. Electric current. Resistivity, resistance and resistors. Ohm's law. Series and parallel resistors. Kirchhoff's principles. Work, power and the Joule effect. Direct and alternating current. Period and frequency. The magnetic field of an electric current. Forces on electric currents in a magnetic field. Electromagnetic induction.

Annex 3 - Citizenship in foreign countries and/or qualifications obtained in a foreign education system

A3.1 - Citizenship in EU and non EU countries with a residence permit in Italy (non-EU citizens treated as equivalent)

Follow the general procedures set out in the call for applications if:

- you are a citizen of one of the European Union countries or one of the following countries: Norway, Iceland, Liechtenstein, Switzerland, the Republic of San Marino, the Vatican City State;
- you hold dual citizenship, one of which is in a European Union country;
- you are a citizen of a non EU country, but hold one of the following residence permits issued by the Italian State:
 - o EU long-term residence permit;
 - o Residence permit for employment or self-employment;
 - o Residence permit for family reasons;
 - o Residence permit for political asylum, subsidiary protection or special reasons;
 - o Residence permit for religious reasons;
 - o Residence card under Article 50 TEU – Article 18.4 of the EU-UK Withdrawal Agreement
- you are a non-EU citizen but have been legally resident in Italy for at least one year and hold a upper secondary school qualification obtained in Italy that grants access to your chosen degree programme, or you hold a degree or an accredited Foundation Year certificate obtained at an Italian university, duly recognised by the Ministry of Education, Universities and Research (MUR), in the 2025/2026 academic year;
- you are a citizen of a non EU country and are duly enrolled on a degree programme at an Italian university, hold a valid residence permit for study purposes and intend to apply for a transfer or progression to years following your initial enrolment;
- you are a non EU citizen and you (or one of your parents or your spouse) are a member of staff serving in foreign diplomatic missions and international organisations based in Italy, accredited to the Italian State or the Holy See. In this case, you must submit your residence permit for diplomatic purposes.

If you hold a residence permit for study in Italy issued for

- attending an Italian language course
- undertaking an exchange/mobility period
- attending a “single course”

follow the instructions provided at [point A3.3](#)

A3.2 – Dual citizenship

If you hold dual citizenship, one of which is Italian or from another EU country, your Italian citizenship or that of the other EU country takes precedence (Law No. 218 of 31 May 1995, Article 19, paragraph 2) and therefore, to enrol on the degree programme indicated in this call for applications, you must follow the instructions provided for those who hold citizenship of an EU country and a non EU country and hold a valid residence permit in Italy (non-EU citizens treated as equivalent).

A3.3 - Citizenship in non EU countries, residence abroad and application for a student visa

If you are a non EU citizen, reside in a country other than Italy and do not meet the requirements set out in [point A3.1](#), you must apply for an entry visa for study purposes, as indicated in [point 2.2](#) in order to enrol on the course specified in this call for applications.

If you are a non EU citizen and hold a residence permit for study purposes in Italy issued to attend an Italian language course or to undertake an exchange/mobility period, in order to enrol on the degree programme covered by this call for applications, you must return to your country of origin and submit an application for an entry visa for study purposes as indicated in [point 2.2](#).

A residence permit for study purposes issued for a “single course” will be considered valid for university enrolment as an EU equivalent only if all three of the following requirements are met in the 2025/2026 academic year:

- You entered the country on a study visa issued specifically for single courses
- You have regularly attended the single course and passed the relevant assessment
- The single course attended is relevant to the degree programme chosen for your subsequent academic career

If even one of the listed requirements is not met, in order to enrol on the degree programme in this call for applications, you must return to your country of origin and submit an application for an entry visa for study purposes as indicated in [point 2.2](#).

A3.4 – ‘Marco Polo’ Programme

If you are a Chinese citizen, have joined the “Marco Polo” project for Sapienza, and have submitted your pre-enrolment application to the Italian diplomatic and consular missions in China for the 2025/2026 academic year, you are eligible to apply for the places reserved for the “**Marco Polo**” project.

A3.6 - Course shortening for holders of a foreign university qualification

If you hold a university qualification from a foreign education system and wish to apply for the recognition of university exams taken abroad, you must submit a request to the International Students' Office, with a € 16.00 revenue stamp, within 30 days of your enrolment date

Procedure:

Following administrative checks, the “Hello - International Students Office” reserves the right to request further documentation if deemed necessary and to reject the application for recognition if the necessary requirements are not met.

Once the necessary checks on the foreign qualifications submitted have been completed, the application will be sent by the Hello - International Student Office to the relevant student office for the administrative process.

Annex 5 - Services for Disabilities and Specific Learning Disabilities (SLDs)

5.1 - Recognised disability/invalidity

If you have a recognised disability under Article 3, paragraph 1 or 3 of Law No. 104 of 5 February 1992, or if you have a disability certificate, and you require special assistance or additional time to take the test, you must indicate your preferences on the Infostud system when paying the test registration fee. You must also send certification relating to your disability/invalidity to testaccesso.inclusione@uniroma1.it. Special cases of extreme severity will be considered based on the certificates submitted.

All requests must be submitted before the registration deadline and accompanied by relevant certification issued by INPS or the relevant S.S.N. (National Health Service) body.

5.2 - Specific Learning Disabilities (SLDs)

If you have been diagnosed with SLD, as defined by Law No. 170/2010 and Ministerial Decree No. 5669/2011, and require special assistance for the test due to your SLD diagnosis, you must indicate your preferences on the Infostud system when paying the test registration fee and send the relevant certification to testaccesso.inclusione@uniroma1.it

Requests must be received by the test registration deadline and must be accompanied by appropriate SLD certification issued by the National Health Service or by specialists and facilities accredited by the latter. If the attached documents do not specify the accreditation of the facilities or specialists who issued the certification, you must add a note confirming this accreditation.

The SLD certification must be detailed and clear, refer to the nosographic codes and explicitly state the SLD (reading, writing, and/or calculation). If the diagnosis was made for minors, it must have been issued no more than three years ago.

5.3 - Disability/invalidity and SLDs for residents of foreign countries

If you reside abroad and have a recognised disability or a diagnosis of SpLD and you wish to take advantage of the benefits described above, you must submit appropriate certification issued in your country of residence, legalised where required by current international regulations.

The certificate must attest to the status of invalidity, disability or SpLD and be accompanied by a sworn translation by an official translator, or certified as a true copy of the original by the competent Italian diplomatic representatives. The documentation must be written in Italian or, alternatively, in English.

Annex 6 - ISEE for the right to university education

The ISEE (Indicator of Equivalent Economic Situation) for the right to university education is necessary to obtain a reduction in enrolment fees (the lower the ISEE value, the lower the amount to be paid). ISEE calculations for university education benefits can be requested from the Tax Assistance Centres (CAF) starting from 15 January 2026 onwards, and at least 30 days before the relevant deadline ([point 8](#)).

Those with a PIN code or SPID digital identity (a unique code for accessing all digital and online services of the Public Administration) can also request an ISEE calculation directly online by submitting a DSU (Dichiarazione Sostitutiva Unica - Single Substitute Declaration) on the INPS website (<https://www.inps.it/it/en.html>).

Foreign nationals who declare income earned abroad and are therefore unable to provide ISEE certification must pay a fixed registration fee based on their country of origin.
